Sabathani Community Center provides affordable, secure facility space to small nonprofits in the community Monday through Friday 6 am to 9 pm and Saturday 9 am until 6 pm. 31 tenant organizations were provided space in the 3-story complex which is completely handicapped-accessible and equipped with an auditorium, conference rooms, gymnasium, full-service kitchens for daycares and day centers, community gardens, a neighborhood museum, playgrounds and more. Resident nonprofits in the building support area residents with utility assistance, translation assistance, rehabilitation services, ethnic (in-language) day cares and youth groups, disability services, LGBTQ support and more. As a result Sabathani Community Center offers a diverse Minneapolis community with quality wraparound services at a single site.

In 2018 the Family Resources programs served 43,452 individuals. The education component of Family Resources continues to have success! 150 students completed employment training modules in the finance, and science industries. 60 individuals 18 and older earned a certified employment credential.

Description: The Sabathani Senior Center assists seniors with maintaining independent living through transportation, health care, health care information and resources, education, social and recreational opportunities. In 2017, we served 1,035 seniors. In about 500 unique events, the Senior Program has provided services including safety classes, mental health counselling, free fitness classes, diabetes prevention, hypertension prevention, recreational opportunities and more.

Expenses: \$23,804 including grants of: \$0 Revenue: \$100

Description: The Health and Wellness Program provides a free medical and a dental clinic for low-income families. In 2016, we served 1,241 individuals. Zumba classes at Sabathani provided 565 area residents with free fitness opportunities, improving the overall health of our community. For community health, it is critical to provide countermeasures to the health disparities often characteristic of low-income neighborhoods. To this end, we connected one-on-one with 450 people through health fairs, and 75 individuals through our Anti-Tobacco work. Our free dental services provided 151 children and pregnant women with necessary dental check-ups.

Expenses: \$95,742 including grants of: \$0 Revenue: \$58,884

Description: In 2017, ninety teens participated in the Horizons STEAM (Science, Technology, Engineering, Arts, and Mathematics) Program. The program focused on a variety of topics, such as critical thinking and problem-solving skills, effective communication, using the Scientific Method, and college and/or career readiness. Students in the summer program took part in a project to design a community garden using STEAM skills they had learned in other program modules, such as calculating mass, volume and area to determine how many plants could grow in the garden, using color theory to create an attractive garden design, and learning to predict rainfall and daylight hours. The students also took part in career-exploration exercises. Ninety-five percent (95%) of youth represent communities of color, including 51% African American, 35% Latino, 14% Somali and 1% Other. The Horizons Youth Program aims to eliminate the achievement gap through a combined curriculum of academic, empowerment, and project based activities.
